Accessibility

HB1582-FN (Law) Providing free tuition at colleges and universities for children of veterans who are totally and permanently disabled; programs to aid veterans' access to employment, housing, healthcare and college degrees; educational assistance for members of the NH National Guard; tuition waivers for children in state foster care or guardianship and prohibiting higher education institutions from discriminating on the basis of military, law enforcement or veterans status.

Discrimination

HB383 Prohibiting discrimination on the basis of sex, gender identity, race, color, marital status, physical or mental disability, religion, creed or national origin in any public school, non-public school or approved school tuition program;

SB455 Prohibiting higher education institutions from discriminating on the basis of military, law enforcement or veteran status; and

SB515 Establishing requirements for school-district, discrimination-prevention policies.

HB1248-L Enabling municipalities to offer community revitalization tax incentives for the construction of additional housing in designated areas. The bill also revises the criteria for assistance from the affordable housing fund administered by the housing finance authority;

HB1317-FN Establishing funding for energy efficiency and renewable energy projects by residential, commercial and industrial ratepayers;

HB1320 Requires landlords of residential property to include in the rental agreement a statement on the purchase of renter's insurance by the tenant;
